FELLOWS OF THE INDIAN POTATO ASSOCIATION

Existing Fellows of IPA are requested to nominate to a maximum of two members in a year for electing new Fellows.

Criteria for electing a Fellow

- i) The member to be nominated should have a standing of a minimum of 5 years in IPA.
- ii) He should not be below the age of 40 years and normally having a Ph.D. degree.
- iii) He should not be below the rank of Assoc. Prof./Sr. Scientist/Reader for 5 years.
- iv) He should have published a minimum of 20 research papers (excluding popular articles and abstracts) on potato.
- v) Application will be called from the nominated members in the presented performa to be put up for an initial screening.
- vi) Total strength of Fellows will not exceed 10% of the total membership of IPA, at any point of time.
- vii) A total of two Fellows may be elected every year starting from 1995.
- viii) A Membership fee of Rs. 2360/- (Rs. 2000 + Rs. 360 GST @18%) for Fellow will be charged from the candidate if he is elected Fellow of the association.
- ix) A committee comprising three following office bearers will screen the application and select the Fellows:
 - 1. President
 - 2. Editor-in Chief
 - 3. Secretary

The Fellows thus selected will be approved by the executive council.

x) If any of the office bearers is contesting, he/she should not be entitled to sit in the committee.
