FELLOW OF THE INDIAN POTATO ASSOCIATION

Existing fellows of IPA are requested to nominate to a maximum of two members in a year for electing new Fellows.

Criteria for nominating a Fellow

1. The member to be nominated should have a standing of a minimum of 5 years in IPA.
2. He/she should not be below the age of 40 years on the 1st January of the year for which he/she is being nominated and normally having a Ph.D. degree.
3. He/she should not be below the rank of Assoc. Prof./Sr. Scientist/Reader for 5 years.
4. He/she should have published a minimum of 20 research papers (excluding popular articles and abstracts) on potato.
5. For non-researchers (farmers, cold store owners, industries *etc.*), criteria at Sr. no. 2 to 4 do not apply. However, their contribution to the cause of potato development in India must be significant and achievements clearly mentioned.
6. A Membership fee for Fellow of Rs. 2360 (Rs. 2000 + Rs. 360 GST @18%) will be charged from the candidate if he/she is elected Fellow of the association.
